Current Surfaces, Inc. is offering a \$1,000.00 Scholarship to any High School Track participant with at least three years experience in the sport to further their education and pursue a productive and rewarding life.

One recipient and the award will be determined by a Scholarship Committee upon review of the scholarship application and letters. The Scholarship Committee will be composed of the following:

1. President
2. Vice President
3. Company Office Administrator
4. Member-at-large

Criteria for Selection:

1. Applicant must be a graduating senior of a High School with an existing Running Track Surface installed by Current Surfaces, Inc. and enrolled in any accredited college, university, vocational or trade school.
2. Applicant must have a G.P.A. of 2.0 or higher and demonstrate such qualities as initiative, honesty, integrity, and community service as well as a strong work ethic.
3. Financial need will not be an absolute criterion for the award, but may be taken into consideration by the Scholarship Committee.
4. Applicants must submit the application form along with one letter of integrity from a teacher/coach and a letter from a non-family member along with a copy of their most recent school transcript.
5. Scholarship award must be used for school related expenses including, but limited to, tuition, room and board, books and lab fees.

Scholarships may not exceed \$1,000.00 annually, and is not renewable. Recipient is eligible to win only one time. If funds are not available in any given year for granting a new scholarship, final determination will be at the discretion of the Scholarship Committee. Scholarship will be paid at the beginning of each semester or term to the school at which the student is enrolled.

Applications for scholarships will be made available though the counseling office of the High School and must be submitted no later than April 23rd of each year. The Committee will award the scholarship by May 14, via letter to school and applicant.
